壹、國際專修部介紹及申請入學時程 International Foundation Program Introduction and Application Schedule

一、何謂國際專修部 What is International Foundation Program

本校2024年初依據教育部核定，設立國際專修部(以下簡稱國專部)，以培育餐旅觀光產業所需之海外青年人才。

In early 2024, our university established the International Foundation Program based on the approval of the Ministry of Education(MOE), with the aim of cultivating overseas young talents needed in the hospitality and tourism industry.

國專部為1+4課程，第1年為華語先修課(不須華語基礎)加上4年學士學位課程。第一年華語先修課期間達到華語文測驗(TOCFL)聽力與閱讀A2標準即可銜接正式4年之學士學位。

The International Foundation Program offers 1+4 programs. The first year focuses on a Mandarin preparatory course (no prior Mandarin knowledge required), followed by a 4-year bachelor's degree program. During the first year, students need to reach the A2 level in listening and reading on the Test of Chinese as a Foreign Language (TOCFL) to proceed to the formal 4-year bachelor's degree program.

本校核定之國際專修部包括: 餐飲管理系四年制、旅館管理系四年制及旅運管理系四年制。歡迎對餐旅觀光產業有興趣之海外僑生與國際學生就讀。

The approved International Foundation Program at our university includes a 4-year bachelor's program in the Department of Food and Beverage Management, a 4-year bachelor's program in the Department of Hotel Management, and a 4-year bachelor's program in the Department of Travel Management. We welcome overseas Chinese and international students who are interested in the hospitality and tourism industry to enroll.

國際專修部學生可申請工作許可證，其工作時間每周最多為20小時。
International Foundation Programs' students can apply for work permits, with a maximum work time of 20 hours per week.

教育部補助國專部華語先修學費台幣30,000元，就讀本校第一年每學期學費為台幣26,000。

With a Ministry of Education subsidy of NT\$30,000 for the 1st year Mandarin preparatory course, the tuition for the first year is NT\$26,000 per semester.

肆、修業年限與課程規劃Program Duration and Curriculum

Instruction

修業年限：華語先修1年＋學士班四年制4年

Program Duration：1-Year Mandarin-language courses (for beginner) + 4-years undergraduate study.

一、 第一年：「華語先修課程」，於本校語文中心華語組研習華語先修課程

The 1st year: “Mandarin Prerequisites Program” is taken in the Mandarin Section of the Language Center

Applying to this program does NOT require a Mandarin proficiency level. NKUHT holds one to two simulated computerized TOCFL exams for International Foundation Program students each semester.

註(2): 所有學生經過第一年的華語先修課程，華語文能力必須通過 A2，未通過者由學校通報退學，學生須依規定離境。達 A2標準者，依學生錄取之各系學士班銜接修讀。

After taking one year of Mandarin prerequisite courses, all applicants must pass A2 level of TOCFL test. Applicants who fail to meet this requirement will be expelled from school and leave the country according to the regulations. Students who have reached A2 proficiency will proceed to study in the bachelor's degree programs in which they have been admitted to.

註(3): 華語先修期間不得轉系或轉學。

Applicants are not allowed to transfer to other departments or other schools while taking the Mandarin Prerequisites Program.

After formally studying in the Bachelor's Program for one year, students can apply for department transfer or transfer to another institution. The department transfer is limited to related fields of study that meet the regulations of the Ministry of Education.

伍、申請資格 Eligibility

申請人資格 Applicant Requirements
須符合下列身份資格之一者，始具備外國學生申請入學之資格： A person of foreign nationality who has never held Republic of China ("R.O.C.") nationality and who meets the following requirements is permitted to apply for admission to an educational institution, in accordance with the provisions of these Regulations: - 具外國國籍且未曾具有中華民國國籍，於申請時並不具僑生資格者。 An individual of foreign nationality who has never held nationality status from the Republic of China ("R.O.C.") and who does not hold an overseas Chinese student status at the time of their application. - 具外國國籍且符合下列規定，於申請時並已連續居留海外六年以上者。 An individual of foreign nationality, according to the following requirements and who has resided overseas continuously for no less than 6 years is also qualified to apply for admission under this regulation: - 申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。

An individual who also is a national of the R.O.C., but does not hold nor has had a household registration in Taiwan.

- b. 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。

An individual who also was a national of the R.O.C. but has no R.O.C. nationality at the time of their application shall have an annulled status regarding their R.O.C. nationality for no less than 8 years after an annulment of R.O.C. nationality by the Ministry of the Interior.

- c. 前二款均未曾以僑生身分在臺就學，且未於當學年度接受海外聯合招生委員會分發。

Regarding individuals mentioned in the preceding 2 subparagraphs, they must not have studied in Taiwan as an overseas Chinese student nor received placement permission during the same year of the application by the University Entrance Committee for Overseas Chinese Students.

3. 具外國國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外連續居留滿六年以上者。

An applicant of foreign nationality, concurrently holding a permanent residence status in Hong Kong or Macao, having no history of a household registration record in Taiwan and, at the time of application, has resided in Hong Kong, Macao, or another foreign country for no less than 6 years is qualified to apply for admission under these regulations.

4. 曾為大陸地區人民具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外六年以上者。

An applicant being a former citizen of Mainland China and holds a foreign nationality, having no history of household registration record in Taiwan, and at the time of application, has resided overseas continuously for no less than 6 years is qualified to apply for admission under these regulations.

註1：所稱海外，指大陸地區、香港及澳門以外之國家或地區。

Overseas as prescribed in paragraph 2 and paragraph 3 is limited to countries or regions other than Mainland China, Hong Kong and Macau;

註2：所稱連續居留，指外國學生每曆年在國內停留期間不得逾一百二十日。

The term “continuously” means that an individual may stay in Taiwan for no more than a total of 120 days per calendar year.

註3：所定六年，以擬入學當學期起始日期（二月一日或八月一日）為終日計算之。

The six year calculation period as prescribed in paragraph 2, paragraph 3 and paragraph 4 shall be calculated from the starting date of the semester (Feb. 1st or Aug. 1st) as the designated due date for the time of study.

Individual eligibility is based on” MOE Regulations Regarding International Students Undertaking Studies in Taiwan” <https://goo.gl/nVdEVV> . If the MOE regulations are revised, the latest MOE regulations shall prevail.“

學歷 Educational background

1. 符合教育部採認之高中、大學或獨立學院畢業者(國際及兩岸教育司網站 <https://goo.gl/4vIUJ6>)。申請學士班者需具國外高中畢業或以上學歷。

Applicants who have graduated from a high school, college or university recognized by the Ministry of Education of Taiwan can apply for admissions (please refer to the website <https://goo.gl/4vIUJ6>).

Foreign students with a foreign high school diploma or above are eligible to apply for undergraduate programs and bachelor's degrees.

2. 具有與我國學制相當之同等學力資格者。請參考入學大學同等學力認定標準，以教育部公布網站為準 <https://edu.law.moe.gov.tw/#lawmenu>

Applicants with equivalent qualifications to the academic degree system of Taiwan can apply for admission. Please refer to the Standards for Recognition of Equivalent Educational Levels for University Admission, as published on the website of the Ministry of Education.

3. 申請人畢業學校須為我國教育部認可或當地國政府權責機關或專業評鑑團體認可，符合教育部「大學辦理國外學歷採認辦法」(<https://goo.gl/29yeFG>)規定之學校或我國政府立案之學校，否則恕不受理申請。

Those institutions from which applicants graduated must be accredited schools approved by the Ministry of Education of the R.O.C. as well as by the “Regulations Regarding the Assessment and Recognition of Foreign Academic Credentials for Institutions of Higher Education”

(<https://goo.gl/IEQcd9>). Otherwise, the application will not be processed.

4. 英制高中中學五年學歷 (Form 5) 申請入學者，於原課程外需增修畢業學分。其增修畢業學分之科目由系所另行訂定之。

Applicants who graduated from Form 5 System (High school of the British system of 5 years) and apply to enter NKUHT need to earn more credits. The course profile will be arranged by each department.

其他規定 Other Requirements

1. 欲申請就讀學士班者，須未曾在我國以外國學生身分申請並完成高中學校學程。
Applicants who have completed secondary education in the Republic of China are not eligible to apply to bachelor's degree programs as foreign students.
2. 須未曾遭入學學校以操行、學業成績不及格或因犯刑事案件經判刑確定致遭退學者。
International students who are expelled from any university/college after admission due to any misconduct, poor academic performance or a conviction under the Criminal Code may not thereafter reapply.
3. 須未曾因違反本校校規情節重大而遭本校註銷選讀資格者。
Applicants who have been previously disqualified from participating in NKUHT courses as a result of any violation of university regulations are ineligible to apply.
4. 須符合招生簡章各系所個別要求之申請條件。
Applicants must meet all individual departmental requirements.
5. 如違反上述任一條件之申請者，經查證屬實後，撤銷入學資格、開除學籍或本校畢業資格，且不發給任何學歷證明。
An applicant who is found to have violated any of the aforesaid rules should be disqualified from admission or have his/her student status forfeited, or the degree diploma issued should be revoked. NKUHT reserves the right to not issue any certificate to such a student.
6. 申請人皆須填寫「國際專修部入學權利義務通知書」(附件3)。另，為利本校審查僑生/港澳生身分及學歷資格規定，請僑生需填寫「華裔身份認定申請表」(附件4)；港澳生須另加填「港澳生報名資格確認書」(附件5)。
All applicants must complete the “International Foundation Program Admission Rights and Obligations Notification” (Appendix 3). In addition, to facilitate the review of overseas Chinese / Hong Kong / Macao student status and academic qualification requirements, overseas Chinese students must complete the “Overseas Chinese Identity Verification Application Form” (Appendix 4), and Hong Kong/Macao students must additionally complete the “Hong Kong/Macao Student Eligibility Confirmation Form” (Appendix 5).



陸、招生及錄取方式Enrollment and Admission Requirements

一、線上報名Apply online (報名網址Website: <https://examstd.nkuht.edu.tw/EnrollSTDFS/>)

- (一) 報名系統開放時間: 2025年12月16日起至2026年3月10日。報名時間截止前未將資料上傳或所附證件不齊全者，一律不予受理，亦不得申請延繳。

Application System Opening Period: From 16th December 2025 to 10th March 2026. Applications will not be accepted if the required documents are not uploaded or if any supporting documents are incomplete before the deadline. No extensions for late submission will be granted.

- (二) 掃描所有相關申請表件，每份文件一個檔案(學歷證件、歷年成績單、財力證明暨財力保證書、護照或身分證件、相關附件、其他系所規定表件請依照上開順序依序取檔名，於報名梯次時間截止前上傳至報名系統，逾期不受理。所有檔案均以PDF檔案上傳，單一項目(如成績單)如有多個電子檔，請自行合併成一個檔案後再上傳。檔案不清楚者，視同資料不齊全，將不予受理。紙本資料不須郵寄，請妥善保存。申請生至多申請兩個系，一個系繳交一份留學計畫書。

Please scan all relevant application forms, and create one file for each document (academic certificates, transcripts of academic records, financial proof and financial guarantee statement, passport or other proof of nationality, and other documents requested). Please give each document a file name in the order mentioned above, and upload them to the system. No application will be processed after the deadline. All files should be uploaded as PDF files. If there are multiple electronic files for a single item (such as a transcript of academic records), please merge them into one file before uploading them. If the file is not clear, it will be deemed incomplete and will not be accepted. Hard copies are not required to be mailed. Each applicant may apply to three departments at most. If the applicant applies to more than one department at the same time, he or she will need to submit a separate study plan for each department.

Within one week of submitting the application documents, please check the system to see if your submission status has been received. If not, it shall be deemed that the application has not been completed yet.

Note: If you are accepted for admission, you will need to submit your diploma and transcripts of academic records or their translation versions to a nearby R.O.C.(Taiwan) Embassies and Missions Abroad for verification and submit

the authenticated diploma and official transcripts of academic records to NKUHT within the specified period after the start of the school year; otherwise, your admissions offer will be revoked.

Application materials are reviewed after being received.

三、通過書面審查者，須參加本校招生主管於當地辦理之實體面試。

The admissions officer of NKUHT will conduct on-site or online interviews in the local areas for applicants who pass the review of application materials.

四、針對有疑慮的、需要進一步了解其學習動機的報名者，約時間電話家庭訪問，如有狀況即篩選淘汰。

For applicants who have questions and need further information, school staff would make an appointment and have a home visit or phone interview.

柒、收費標準 Tuitions, fees and other costs

(1) 華語先修期間收取費用 Mandarin Prerequisites Program Tuition

每人每學期收取新台幣26,000元學雜費/每學期。另有代收轉付項目：醫療保險、全民健康保險。

*未符合加入全民健保之境外生，必須投保本校提供之境外生團體保險，500元/月，預收6個月。考量學生的居住安全及校方管理方便，所有學生均安排住在校園內宿舍，住宿費NTD 11,500~14,200。

The tuition for each semester of the first year Mandarin Prerequisites Program is NTD 26,000 /semester. Other fees, including medical insurance and national health insurance, will be collected separately.

*International students who have not yet joined the National Health Insurance must join the group insurance. The fee is NT\$500 per month, payable for six months at a time. To ensure the safety of students and in accordance with campus management principles, all applicants will be arranged to live in school dormitories. Dormitory fees are 11,500~14,200 NTD/semester

International Foundation Program

Notice of Rights and Obligations

1. 依教育部辦法規範申請來臺就讀，以一次為限。於完成申請就學學校學程後，除申請碩士班以上學程，得逕依各校規定辦理外，如繼續在臺就學者，其入學方式應與我國內一般學生相同。

Application for studying in Taiwan is based on terms and regulations from the Ministry of Education, limited to one-time only. After applying (except for master's degrees or above), please follow the regulations of each school.

2. 學生成績分學業、操行兩種，以一百分為滿分、六十分為及格，成績不及格或不通過之科目，不給予學分；操行不及格(低於60分)，經審議，予以退學。 Grades will be measured by an academic score and a conduct score, with 100 indicating a full score and below 60 as a failing score. Credits will not be given for subjects that are failed. Students with a failing conduct grade (less than 60) and who have been sanctioned by a student disciplinary meeting are subject to being expelled by the university.

3. 學生需於學校規定時間內繳交學雜費與其他費用，若未依規定時間繳交者，將依逾期未註冊理由，處以退學。

Tuition and other fees must be paid during the semester. Students will be expelled if not able to pay on time.

4. 因學生使用學生簽證入學，若有休學、退學，必需於10天內離境。被退學之學生，將失去申請台灣各大學學士以下級別之使用外國學生身分入學之資格。若休學後復學，需重新辦理居留簽證與換發居留證。

Students must leave Taiwan within 10 days after withdrawing from school or being expelled. Students who are expelled will not be eligible to apply for any undergraduate (or below) degree in Taiwan as an international student. For reinstatements after approval to leave, students must re-apply and renew their Alien Residence Certificate.

5. 修習華語第一年及正式進入所屬專業科系之第一年皆規定必須住校，且由學校统一安排宿舍別，以確保學生安全及學習輔導與管理。

In the first year of studying Mandarin and the first year of formally enrolling in their respective academic programs, students are required to live on campus. The university will arrange the dormitories to ensure the safety of students and provide academic support and management.

Leave of Absence: The necessary procedures must be completed in advance during the school term. Failure to do so without special reasons will be considered as an unexcused absence.

7. 學生於考試時如有作弊行為，一經查出，除該次成績以零分計算外，並視情節輕重分別予以記過、勒令退學或開除學籍之處分。

If cheating is found during a test, the grade will be counted as 0. Also, students may receive demerits or face the possibility of expulsion, depending on the situation.

8. 學生可依規定勞動部申請工作證，無校外工作證或違反政府規定工讀時數(工讀時數學期間每周最多20小時，實際依勞動部相關勞動規定辦理)經查學校或任何單位查獲者，將有罰款並有立即遣返回國之可能性。

According to the regulations, students may apply for a work permit from the Workforce

Development Agency. Without a valid work permit, or if not abiding by working hour regulations

(maximum 20 hours per week during semester), the student may be fined or even be expelled/deported back to one's country of origin. Please contact the Overseas Students Service Center in each department to which you belong to get further support for working outside campus.

Smoking and any use of alcohol are strictly prohibited on the campus, and violation may result in both school and criminal penalties.

Smoking, drinking, cooking, keeping weapons, having gas stoves, using high electricity consumption electrical devices, making noise, staying outside overnight, etc. are prohibited in the dormitory. For security reasons, 23:00 has been set as a curfew every night, in which one will not be allowed to leave the dormitory from 23:00 to 5:30. The dorm supervisor will take a roll call at 23:00 every Sunday to Thursday. Punishment will be enacted upon anyone who violates these regulations.

Residents are not allowed to damage public property, and violators will be held liable for compensation at the full price.

Holders of the R.O.C. (Taiwan) resident certificate (ARC) must extend the residence permit certificate (ARC) renewal online within 3 months before the residence permit expires. The fee is NTD\$1,000/ per year. Please check the valid date yourself. The office of the International Foundation Program will assist in applying for the first-time application.

Students who fail to meet this requirement will be subject to expulsion procedures.
- (2) Students who achieve the A2 standard will be admitted to the Bachelor's (Specialized) Program or respective undergraduate programs. Students are required to reach a B1 level in Chinese language proficiency before the second year of their study in the undergraduate program. Students who do not meet this requirement must participate in Chinese language tutoring courses offered by the Chinese Language Teaching Center at their own expense until they reach the B1 level or above to graduate.
- (3) Applicants are not allowed to transfer to other departments or other schools while taking the Mandarin Prerequisites Program. After formally studying in the Bachelor's (Specialized) Program for one year, students can apply for department transfer or transfer to another institution. The department transfer is limited to related fields of study that meet the regulations of the Ministry of Education.
